## Official Rules

? All valid paid entries, free mail-in entries, and eligible membership entries for that Promotion are combined into a single random draw pool.

? Grand Prize drawings for launch Promotions are scheduled for Sunday, July 5, 2026 at approximately 8:00 p.m. Eastern Time, streamed live on YouTube, unless otherwise stated in a Promotion section.

? Pre-sale entries purchased before the public launch date are held and assigned entry numbers before the applicable drawing, subject to payment confirmation and eligibility verification.

#### **4. How to enter (paid)**

During each Promotion's Promotion Period, eligible persons may obtain entries by visiting [gaviom.com](http://gaviom.com), selecting a Promotion, choosing an entry bundle, and completing checkout with a valid payment method.

Entry price: From \$12 USD per entry

Round-trip from Montreal (YUL) to Cozumel, 7 nights all-inclusive, PADI discovery scuba program for two.

## 8. Promotion #3 - Las Vegas (Sweepstakes #3)

Sweepstakes ID: #3

Maximum entries: 4,800

Entry price: From \$10 USD per entry

### Prize (ARV \$4,200 USD)

Round-trip airfare to Las Vegas for two, four nights Strip-view suite, dining/show credits.

## 9. Promotion #4 - iPhone 17 Pro Max (Sweepstakes #4)

Sweepstakes ID: #4

Maximum entries: 3,000

Entry price: From \$7 USD per entry

### Prize (ARV \$1,299 USD)

One Apple iPhone 17 Pro Max 256GB with two years AppleCare+.

## 10. Gaviom+ membership

Price: \$17 USD per month, billed monthly. Cancel anytime.

### 10.1 What members receive

? Five (5) tickets per month starting month 1, plus one (+1) bonus ticket for each consecutive month subscribed, up to eight (8) tickets per month (month 4 and beyond).
